Overview

- ▶ Third major housing plan in the last decade, second in the last four years
- ▶ Targets **300k** homes built by year-end 2030, including **72k** social homes and **90k** affordable homes
- ▶ Focused around two pillars:
 1. Activating Supply
 2. Supporting People



Breakdown of pillars

Both Pillars are split up into 4 key priorities

Govt. commitment on accountability: “Each priority contains a suite of actions building on progress to date. The implementation of each action will be led by a named Government department, State Agency, or other body. Progress on the implementation of these actions will be regularly monitored and reviewed by the Cabinet Committee on Housing, ensuring effective oversight, accountability, and the timely delivery of all actions. **Effective monitoring of progress must be supported by reliable quantitative metrics.**” (p.9)



New housing target

- If met, the ambitious new housing target would **surpass** the number of units built since the beginning of 2009
- New housing target is accompanied by a need for an estimated **€20bn in development finance each year**
