# **Safe Pass Subsidy for Transition Year Students**

## **Explanatory Note**

### **0.0 Background**

SOLAS and the Construction Safety Partnership Advisory Committee (CSPAC) have collectively engineered a support mechanism for Safe Pass cards for transition year secondary school students. This relationship is underpinned by financial governance to provide a subsidy of ten euros (€10.00) only per transition year student on a first come, first served basis for a three-year period (2019 through 2021).

The SOLAS Safe Pass programme would benefit persons undertaking transition-year schooling, particularly those with an interest in engineering and construction, in terms of heightened awareness of health, safety and wellbeing. Many young persons seek work experience during the school holidays and at weekends. The construction industry seeks to encourage students to consider a career in the sector, which offers an exciting and diverse range of roles for all persons.

It is a mandatory requirement for students or temporary staff on construction sites (and other categories not specified) to obtain Safe Pass Health and Safety Awareness Training Programme in advance of work commencement; this enables them to work on-site without being a risk to themselves or others who might be affected by their acts or omissions.

### **1.0 Rules**

All applicants under the subsidy scheme must meet the criteria of being an existing transition year student, meet the fees due for the Safe Pass scheme and apply for a subsidy only after completing the Safe Pass training.

### **2.0 How to Apply**

Applications for a subsidy against applicable fees for the SOLAS Safe Pass card shall be made in writing, utilizing the application form provided, by email to: [TYSafePass@cif.ie](mailto:TYSafePass@cif.ie) or by postage to:

Following confirmation that each student had undertaken Safe Pass training, the CSPAC would issue a cheque made payable to the school for refund of ten euros (€10.00) per transition year student.
